Manager Commentary

Market Overview

Global equity markets saw continued declines during the third quarter as the summer rally came to a halt following hawkish rhetoric from the U.S. Federal Reserve's Jackson Hole meeting. International equity markets are dealing with elevated and rising inflation, decelerating global economic growth, tightening financial conditions, and exceptional U.S. dollar strength. The strength of the American currency accelerated the exportation of U.S. inflation trends to the rest of the world, forcing nearly all global central banks to follow the U.S. Federal Reserve in raising interest rates. Tighter financial conditions forced global equity and fixed income markets to reduce investment positions and leverage, driving nearly all asset classes lower.

The MSCI EAFE Small Cap Index declined by 9.83% during the third quarter, and the Vaughan Nelson International Small Cap was in line with that performance. The bulk of the decline was driven by U.S. dollar strength. Communication Services was the worst performing sector, while Energy was the only sector with positive returns.

Portfolio Positioning

As a result of buys, sells, and market action, the portfolio is overweight Information Technology, Industrials, Consumer Staples, and Health Care while underweight Real Estate, Consumer Discretionary, Materials, Utilities, Financials, Energy, and Communication Services.

Contributors to Performance

During the quarter, the strategy returned negative absolute and negative relative performance. Positive contributions from Real Estate, Consumer Staples, Financials, Industrials, Utilities, and Communication Services were offset by Consumer Discretionary, Materials, Energy, Information Technology, and Health Care.

Outlook

Economic deceleration and a weaker consumer are visible. We see clear risks in Europe, with geopolitical concerns tilting towards the downside where a multi-decade spike in inflation meets the end of a multi-decade slide in interest rates and the withdrawal of more than a decade of central bank stimulus.

Considering the macro and geopolitical uncertainties, the impending winter related energy risks, and downgrades in earnings expectations, we believe our portfolio is positioned prudently.

The asset class opportunity is incredibly strong. We would not be surprised to see initial positive returns driven by currency rather than price movement, however, in a reversal of this quarter's performance drivers.

NOTES

COMPOSITE DESCRIPTION. Effective 10/1/2019, this composite is comprised of all fee-paying, discretionary International Small Capitalization portfolios in excess of \$1 million under management. Prior to 10/1/19, the composite consisted of all non-restricted, fully discretionary, taxable and tax-exempt accounts which were managed in accordance with the International Small Capitalization Value strategy at Advisory Research, Inc. Effective 10/1/19, the strategy name was changed to International Small Capitalization in order to appropriately reflect the characteristics of the strategy. The International Small Capitalization strategy primarily invests in non-U.S. equities and principally in developed markets with a market capitalization generally within the range of the MSCI EAFE Small Cap Index (Europe, Australasia, Far East). The index is a free-float-adjusted market capitalization index that is designed to measure the equity market performance of developed markets, excluding U.S. and Canada. The index is reported net-of-dividends which indicates dividends are reinvested after the deduction for withholding taxes, using a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties. MSCI is the source and owner of MSCI Index data contained herein. Any further dissemination of the data is strictly prohibited. MSCI is not responsible for any inaccuracy in this presentation. The composite creation and inception date is 11/30/13. **FIRM DEFINITION.** Vaughan Nelson Investment Management ("Vaughan Nelson") is an equity, fixed-income and balanced portfolio investment manager. Vaughan Nelson is defined as an independent investment advisory firm and is affiliated with Natixis Investment Managers, LLC. **FEES.** International Small Capitalization Fee Schedule: 1.00% on the first \$25 million, .85% on the next \$75 million, .80% on the remainder. **OTHER NOTES.** Performance results are presented before management fees. Results for the full historical period are time weighted. Accounts have been valued daily and portfolio returns have been weighted by using beginning-of-month market values plus daily weighted cash flow. The dispersion calculation is based on a dollar-weighted average of gross portfolio returns within the composite for the entire period. The dispersion percent of N/A indicates that the number of portfolios for the entire year were equal to five or fewer or periods of less than one year. The benchmark source is FactSet. The valuation source is Intercontinental Exchange (ICE). Benchmark returns are not covered by the report of independent verifiers.

Portfolios meeting the stated criteria are added to the composite as of the first full quarter of investment in that composite's style. Similarly, accounts are removed from the composite after the last full quarter of management under the composite style. A list of all composites and pooled fund investment strategies offered by the firm, with a description of each strategy, is available upon request. The composite results portrayed reflect the reinvestment of dividends, capital gains, and other earnings when appropriate. The U.S. dollar is the currency used to express performance. **CALCULATION METHODOLOGY.** The composite performance results are time-weighted total returns net of commissions and transaction costs. Valuations and returns are expressed in U.S. dollars. Vaughan Nelson consistently values all portfolios each month on a trade date basis. Additional information regarding policies for valuing portfolios, calculating performance, and preparing GIPS Reports are available upon request. Net-of-fee returns are calculated utilizing the highest annual fee paid by a client in the strategy. This fee is divided by 12 and subtracted from the gross composite return on a monthly basis to calculate monthly net of fee returns. Quarterly and annual net-of-fee returns are calculated by geometrically linking these monthly returns. **COMPLIANT STATEMENT.** Vaughan Nelson claims compliance with the Global Investment Performance Standards (GIPS®) and has prepared and presented this report in compliance with the GIPS® Standards.
