MANAGER COMMENTARY
Market Overview

The performance of the asset class during the third quarter can be divided into two parts. The first continued trends from the second quarter, with strong positive absolute returns, relative stability in currencies, positive or neutral macro news, no threatening COVID 19 news and favorable factor development.

At the beginning of September, however, the narrative and the market focus began to change. The news of Evergrande's, the Chinese real estate developer, potential default created concerns about a systemic crisis in China and that knocked the air out of emerging markets. In developed markets, supply chain constraints and renewed fears of stickier, higher inflation led to a risk-off environment that added to the concerns. Inflation fears led again to a change in factor leadership during the last weeks of the quarter, with the value factor replacing what had been an outperforming growth factor.

Inflation fears also caused USD interest rates to rise which supported an appreciation of the dollar against the basket of our currencies, eroding the returns considered in USD.

Additionally, some one-off situations affected our geographies, for example, gas prices in Europe. The spot prices trended significantly higher not just due to the increase in activity, but also because of external conditions reducing the availability of solar and wind energy. The spike in energy prices led to a reduction of activity in some industries and to margin constraints in others which will be visible when third quarter results are announced.

Portfolio Positioning

As a result of buys and sells and market action, our weightings in Germany, Austria, France, and Belgium increased during the quarter. The portfolio's weightings in the United Kingdom, Sweden, Switzerland, and Singapore decreased during the quarter. The lower UK weighting was primarily because of four takeovers that we had during the second quarter.

From a sector perspective, our weightings in Health Care, Energy, and Industrials increased during the quarter. The portfolio's weighting in Financials, Real Estate, Information Technology, and Consumer Discretionary decreased during the period.

Contributors to Performance

During the quarter, the portfolio experienced modest absolute performance and slightly lagged its benchmark. The strategy returned 0.37% during the third quarter compared to the MSCI EAFE Small Cap Index's increase of 0.89%. The best performing countries (total effect) were France, Hong Kong (due to our underweight position), and Singapore. The portfolio underperformed in Belgium, Japan, Netherlands, Norway, and Sweden. The portfolio continues to be overweight Industrials and Information Technology while underweight to Real Estate, Consumer Discretionary, Materials, and Utilities. Our biggest country overweights are to the United Kingdom, France, Germany, and Norway which is offset by underweights to Australia, Sweden, Italy, and Switzerland.

Outlook

The global economic scenario left us with fewer certainties at the end of the quarter with several concerning areas in the short-term including companies with significant Chinese exposure, complex supply chains, energy intensiveness, exposure to raw materials, and/or inability to pass higher costs, among others.

Globally we see economic activity continues at effective levels but with a decelerating trend, and that seems to be the case for most of our geographies.

We added nine names to the portfolio during the third quarter. We also exited nine names during the quarter. Two of these positions were the result of successful takeover offers.

We continue to be highly encouraged by the opportunity in the international small cap space. The Vaughan Nelson investment approach with its macro awareness and deep fundamental research, coupled with valuation discipline, allows us to navigate the fluid market conditions and identify attractive investment opportunities that meet our targeted return objective.

COMPOSITE DESCRIPTION. Effective 10/1/2019, this composite is comprised of all fee-paying, discretionary International Small Capitalization portfolios in excess of \$1 million under management. Prior to 10/1/19, the composite consisted of all non-restricted, fully discretionary, taxable and tax-exempt accounts which were managed in accordance with the International Small Capitalization Value strategy at Advisory Research, Inc. Effective 10/1/19, the strategy name was changed to International Small Capitalization in order to appropriately reflect the characteristics of the strategy. The International Small Capitalization strategy primarily invests in non-U.S. equities and principally in developed markets with a market capitalization generally within the range of the MSCI EAFE Small Cap Index (Europe, Australasia, Far East). The index is a free-float-adjusted market capitalization index that is designed to measure the equity market performance of developed markets, excluding U.S. and Canada. The index is reported net-of-dividends which indicates dividends are reinvested after the deduction for withholding taxes, using a tax rate applicable to non-resident institutional investors who do not benefit from double taxation treaties. MSCI is the source and owner of MSCI Index data contained herein. Any further dissemination of the data is strictly prohibited. MSCI is not responsible for any inaccuracy in this presentation. The composite creation and inception date is 11/30/13.

FIRM DEFINITION. Vaughan Nelson Investment Management ("Vaughan Nelson") is an equity, fixed-income and balanced portfolio investment manager. Vaughan Nelson is defined as an independent investment advisory firm and is affiliated with Natixis Investment Managers, LLC.

FEES. International Small Capitalization Fee Schedule: 1.00% on the first \$25 million, .85% on the next \$75 million, .80% on the remainder.

OTHER NOTES. Performance results are presented before management fees. Results for the full historical period are time weighted. Accounts have been valued daily and portfolio returns have been weighted by using beginning-of-month market values plus daily weighted cash flow. The dispersion calculation is based on a dollar-weighted average of gross portfolio returns within the composite for the entire period. The dispersion percent of N/A indicates that the number of portfolios for the entire year were equal to five or fewer or periods of less than one year. The benchmark source is FactSet. The valuation source is Intercontinental Exchange (ICE). Benchmark returns are not covered by the report of independent verifiers.

Similarly, accounts are removed from the composite after the last full quarter of management under the composite style. The composite results portrayed reflect the reinvestment of dividends, capital gains, and other earnings when appropriate. The U.S. dollar is the currency used to express performance.

CALCULATION METHODOLOGY. The composite performance results are time-weighted total returns net of commissions and transaction costs. Valuations and returns are expressed in U.S. dollars. Vaughan Nelson consistently values all portfolios each month on a trade date basis. Additional information regarding policies for valuing portfolios, calculating performance, and preparing GIPS Reports are available upon request. Net-of-fee returns are calculated utilizing the highest annual fee paid by a client in the strategy. This fee is divided by 12 and subtracted from the gross composite return on a monthly basis to calculate monthly net of fee returns. Quarterly and annual net-of-fee returns are calculated by geometrically linking these monthly returns.
